Official Rules

Entries may also be mailed to either KFSM Studio: KFSM-TV P.O. Box 369 Fort Smith, AR 72902 or KFSM-TV 4201 North Shiloh Drive, Suite 169 Fayetteville, AR 72703. To be eligible KFSM must receive all mailed entries by 12:00 PM CST August 11, 2012. Entries may also be dropped off at any Bedford Camera location by close of business on August 11, 2012. Winner will be announced on Friday, August 17, 2012. After the winners are announced, photographs may be picked up at the Bedford Camera & Video where you originally dropped them off. Please allow two weeks. All entries should be no smaller than 3x5 and no larger than 5x7. Each

entry must have name, address and phone number on the back of each photo. Also include name and age of person/persons in the picture. No electronic or digital submissions will be allowed. Incomplete entries will be disqualified. Entrants may be required to become registered users of the website and may not enter the Contest more than once. Only one prize per person, household, or email address allowed. Duplicate entries will not be accepted.

- **4. Prize:** 1st, 2nd, and 3rd place prizes will be awarded. The 1st place winner will receive a Canon Rebel T3i w/18-55 IS lens, CanonEF 55-250 IS lens, Promaster 8GB SD card, SLR Camera Case, two Promaster UV protection filters, Promaster 7100 tripod, and Bedford 200 Pre-Paid Digital Card.
